5. LIMITATION OF LIABILITIES AND COMMITMENTS

A. MCH Private Equity shall REFRAIN FROM PRODUCING ANY MISLEADING ADVERTISING through their Website. Receive, in a structured and widely used machine-readable format, the Personal Data concerning you that you have provided to MCH Private Equity or request that MCH Private Equity transfers it directly to another data controller where technically feasible.

Withdraw the consent given, although in certain circumstances it may be lawful for MCH Private Equity to continue to process your Personal Data where MCH Private Equity has a legitimate reason (other than consent) for doing so.

To lodge a complaint with the relevant data protection authority if you believe that MCH Private Equity has breached any of your rights.

In order to exercise these rights and in compliance with current legislation, you must prove your identity to MCH Private Equity by sending a photocopy of your National Identity Document or any other legally valid means.

MCH Private Equity undertakes that all communications of your personal data will be considered confidential, and will not be communicated at any time to third parties outside the contractual relationship between you and the companies.
